The Government of Haryana had floated a scheme called Educated Youth Allowance and Honorarium Scheme, 2016, to provide monthly unemployment allowance to educated youth and honorarium to eligible post graduate applicants for honorary assignment in various Departments/Boards/Corporations/Registered Societies etc. under Haryana Government and in Private Companies/Enterprises. Petitioners were also accordingly granted honorarium assignment with effect from 8.3.2017, Petitioners were called Saksham Yuvas. which was to end on 8.9.2019. Petitioners were performing their honorarium duties. Now, vide letter dated 8.5.2018, all the Saksham Yuvas have been relieved from their work assignments immediately without giving any notice as respondents No. 1 and 2 have started rotation policy (Annexure-P-5).

natter of concession. If that scheme has been modified, petitioners cannot claim honorarium as a matter of right. The Government can always make necessary modification in the Scheme. The rotation policy of providing honorarium assignments to similarly situated other Saksham Yuvas appears to be modification of scheme. Therefore, petitioners have got no vested right to continue till 8.9.2019. As such, no direction can be issued to State Government to allow petitioners to continue till 8.9.2019. Consequently, civil writ petition is dismissed.

The learned counsel for petitioners further contends that their honorarium allowance for period in which they worked has not been released to them.

It being so, petitioners can make appropriate prayer before concerned authority, which shall consider same and take necessary action in the matter to release honorarium for the period petitioners worked on honorary assignment.
